

Institute of New Structural Economics at Peking University Ph.D. (Direct Entry) Program Overview (For Trial Implementation)

The direct-entry Ph.D. program in the Institute of New Structural Economics requires five years of study to complete. It includes (1) the foundation courses of economics and the comprehensive examination (namely Doctoral Qualifying Examination); (2) courses in the domain of new structural economics and examinations; (3) working on the research paper in the second school year; (4) forming of the advisor team; (5) working on the research paper in the third school year; (6) completion of at least 46 credits (excluding foreign language and politics courses); (7) attendance of the new structural economics workshop; (8) overseas exchanges (optional); (9) attendance of the new structural economics practices (select 2 practices out of three in curriculum setting); (10) visits and exchanges in higher education centers or institutes of new structural economics (optional); (11) doctoral dissertation and defense.*

* For those candidates who cannot complete the Ph.D. program due to special circumstances, they can apply for Master of Economics of Peking University with the joint approval of the Dean and their advisors on the premise that they meet time requirement of China's master program and academic requirements of Master of Economics program of NSD at Peking University and they pass the dissertation defense of new structural economics.

1. Theories of Marxism

Time: the first year, arranged by the Institute

2. The first foreign language

Time: English: the second semester

Other languages (candidates can choose other languages as their first foreign language only when their application is approved): within the first year

Arranged by the Institute

3. Comprehensive (qualifying) examination

Time: at the end of the second semester (mid-July), generally

Content: as required according to regulations; students should be approved before taking the examination

4. Second-year research paper

Time: before the end of the fourth semester

Content: need to be approved and reviewed by the Academic Committee of at least three faculty members

5. Qualifying examinations of concentration courses

Time: at least one examination of concentration courses of new structural economics (* courses in curriculum setting C) is required to be taken within the second year and all examinations are required to be taken no later than the third year

Content: at least 9 credits of * courses in curriculum setting C

6. Attending think-tank projects of new structural economics in China and abroad

Time: before the dissertation proposal

Content: arranged according to the operating requirements and time of actual events

7. Overseas exchanges: overseas higher education institutions or international policy research institutes

Time: the third/fourth year, 6-12 months

Content: discuss with advisors, contact advisors from overseas higher education institutions or international policy research institutes (IMF or World Bank etc.) through candidates' advisors in China, prepare focused and detailed research plan. Government-sponsored or institute-sponsored exchanges are subject to according regulations.

8. Visits to and exchanges in other new structural economics centers (in other domestic universities)

Time: the third/fourth/fifth year, 1-3 months

Content: discuss with advisors, recommended to visit centers or institutes of new structural economics nationwide, including Tsinghua University, Fudan University, Zhejiang University, Wuhan University, Huazhong University of Science and Technology, Tianjin University, Xiamen University, Jilin University, Tibet University, Southwestern University of Finance, Yunnan University of Finance, East China University of Political Science and Law, Xi'an Jiaotong University, Guangzhou University, etc.

9. Third-year research paper

Time: at the end of the 6th semester. Those who have overseas exchanges should report to their advisors as soon as they come back to China. The deadline for reporting is no longer than 2 weeks after their coming back.

Content: need to be approved and reviewed by the Academic Committee of at least three faculty members

10. Dissertation topic report (proposal) & forming of the advisor team

Time: the 7th semester

Content: the panel should include 3-5 experts of new structural economics and economics with the student's doctoral advisor serving as the head of the team; the proposal must include a completed paper and outlines of the second and third papers that have been validated

11. Full-examination of the dissertation (pre-defense)

Time: 3-5 months before defense

Content: form an expert team with at least 5 members;

The dissertation should be completed independently. The three papers are required to present a systematic, complete and innovative academic paper

12. Ph.D. Dissertation Review (Anonymous Review)

Time: submit the dissertation 45 days before the defense

Content: as required by regulations

13. Review and Approval of Dissertation Defense

Time: a week before the defense

Content: submit complete materials as required

14. Ph.D. Dissertation Defense

Time: before the deadline required by the Graduate School

Content: as required according to regulations

15. Publishing of Research Paper

Two research papers are published in core journals in China or abroad

(Not a requirement. The list of core journals in China can be referred to in the latest list 2014 version in Peking University Library)

C. New Structural Economics Concentration Courses

Note that not every course is open in every school year; candidates must select courses related to new structural economics and economics; those who intend to select courses beyond the Institute of New Structural Economics or the National School of Development need to obtain consent of their advisors and report to the office of the Institute, and the credit for such courses shall not exceed 1/3 of the total credits.
