About INSE

Who Are We?

The Institute of New Structural Economics at Peking University (hereinafter referred to as the "INSE") is a pilot academic institute in China that aims at achieving the independent theoretical innovation of social sciences. Its predecessor, the Center for New Structural Economics (hereinafter referred to as the CNSE), was founded by Prof. Justin Yifu Lin, former World Bank Chief Economist and Senior Vice President, in December 2015, as one of China Top Think Tanks.

What is New Structural Economics?

Proposed and championed by Prof. Justin Yifu Lin and his collaborators, New Structural Economics is a theory of economic development, transition and operation. Guided by historical materialism, NSE applies the neoclassical approach to the study of the determinants of economic structure and their evoluation. The starting point of analysis is factor endowments and their structure which is given at any specific time and changable over time. It studies technology and industry that determine the productivity of the economy, and the infrastructure and institutions which determine the transaction costs. NSE maintains that developing countries or regions should develop industries that conform to their comparative advantages based on their factor endowments structure. It seeks synergies between an effective market and a facilitating government in an effort to achieve economic transformation and upgrading as well as economic and social development.

Our Goal

Drawing lessons from development experiences of China and other developing countries, the INSE aims to serve as a leading academic institute and a world-class flagship think tank by pioneering NSE theoretical innovation, application and dissemination.

Our Mission

The INSE facilitates NSE academic research, policy practice, talent cultivation, and international exchange, to empower the scholars, experts, students and government elites in developing countries who are committed to long-term economic development with NSE ideas, theories and instruments so that they can draw a road map to modernization that suits the characteristics of their own countries.

"Seeking knowledge from practice; guiding practice with knowledge; validating knowledge by achievement; integrating knowledge and achievement." The INSE seeks to integrate theoretical innovation with development practices. It holds that true knowledge must be validated by practice, and only true knowledge can benefit the mankind.



Networks of NSE Research Centers

Establishing NSE research centers with universities and policy practice institutions in partnership, INSE aims to promote in-depth research and application of NSE in academic research, policy practice, talent cultivation and other fields, forging a NSE community of theory and practice to raise its influence at home and abroad. INSE conducts in-depth exchanges and cooperation with the NSE Research Centers in cooperative schools in high-level academic research, think tank consultation, talent cultivation, database building, and international exchanges. By the end of 2018, twenty-three higher education institutions in China, such as Tsinghua University, Zhejiang University, Jilin University, Xi'an Jiaotong University, and Guangdong Academy of Social Sciences, have established or are going to establish their NSE Centers.

Global Research Consortium on Economic Structural Transformation (GReCEST)

Initiated by the INSE, GReCEST was inaugurated at the headquarters of the United Nations on May 18, 2016 in New York, with 33 founding members including research institutions and international organizations from developed countries in Europe and North America and from developing countries in Asia, Africa and Latin America. GReCEST is the first consortium under the umbrella of the Global Coalition of Think Tank Networks for South-South Cooperation. It aspires to build a platform for bridging frontier academic thinking and policy practice by conducting exchanges and mutual learning to help developing countries achieve economic structural transformation. Its functions include: set the research agenda on economic structural transformation and related fields; organize annual conferences, set up international development flagship fora and build up a world-class platform for academic exchanges; mobilize resources to support the consortium's activities, projects and operation; publish academic publications on economic structural transformation including papers, monographs, proceedings and working papers.

Local Policy Research and Practice Centers (LPRPCs)

LPRPCs, established by the INSE, are a pilot project for developing the first group of China Top Think Tanks. They serve as one of the major platforms that host policy implementation networks. Collaborating with local governments in major regions, local think tanks and research institutes, the INSE will carry out longitudinal surveys, offer policy-related consulting service, participate in local policy making process, assisting local industrial upgrading, learn lessons from local experiences of economic development, conduct solid case studies, conceptualize development models, and provide feedbacks to the theoretical development of NSE. The INSE and local governments, working through LPRPCs, will collaborate in policy research, short training programs, personnel exchange, investment promotion, and data collection and so on. By the end of 2018, three LPRPCs had been established in Hotan, Xinjiang Uygur Autonomous Region, Yangtze River Delta (Shaoxing), and Datong, Shanxi Province.

Department Introduction

The INSE is one of China Top Think Tanks. Guided by "seeking knowledge from practice; guiding practice with knowledge; validating knowledge by achievement; integrating knowledge and achievement", it consists of three policy practice departments that actively apply the theories and instruments of NSE to development practice.

Domestic Think Tank Department

Guided by NSE theory, the Domestic Think Tank Department assists governments and enterprises at all levels to carry out industrial transformation and upgrading practices, and promotes theoretical innovation from the feedback on policy practice applications. The main tasks include: providing think tank reports and policy recommendations to policy makers in the central government; providing services for local governments, such as policy consultation and implementation evaluation, by taking on commissioned research or co-building the Local Policy Research and Practice Centers; tracking the forefront of industrial development, promoting research and application of industrial policy by co-building industrial laboratories with leading enterprises.

Department of International Development Cooperation

Guided by NSE theory, the Department of International Development Cooperation aims to bring the theory and its policy tool, the "Growth Identification and Facilitation Framework (GIFF)", into practice, following the "the unity of knowledge and achievement" approach. 

In September 2016, the world's top economists, including Justin Yifu Lin, Kaushik Basu, François Bourguignon and Joseph Stiglitz, the four former Chief Economists and Senior Vice Presidents of the World Bank Group, attended an international meeting organized by the Swedish International Development Cooperation Agency (SIDA) and the World Bank in Stockholm, Sweden, to discuss the challenges faced by today's economic policymakers and the principles of world policy making. The outcome of the meeting is the "Stockholm Statement", which summarizes the eight consensuses on the principles of policy making for the contemporary world.

International Cooperation

Symposium on Structural Transformation and Upgrading for the World Economy: Theory, Plan and Opportunity for China

Received more than 400 representatives from embassies and consulates in China, international organizations, foreign industrial parks, and experts from the government, industry, academia and financial sectors in China. The first flagship report of new structural economics titled "World Economic Structure Transformation and Upgrading Report: The Road to New Structural Economics" was released. (May 2017, Peking University)

Think Tank Projects

International Development Cooperation-National Development Projects

1. Ethiopia: Leveraging Comparative Advantages to Quickly Overcome the First Mover Dilemma and Realize Early Industrialization

In 2011, Prof. Justin Yifu Lin suggested to the incumbent Prime Minister of Ethiopia to develop the shoemaking industry, which fits Ethiopia's comparative advantages. He suggested that the government needs to play a facilitating role in attracting foreign investors by policy incentives. Following his suggestion, the Prime Minister then personally came to China to attract investment and successfully convinced Huajian, a leading Chinese footwear maker, to invest in Ethiopia. Huajian quickly became the largest exporter of Ethiopia, creating nearly 10,000 jobs and 20 million USD in export value. The success of Huajian created a snowballing effect to Ethiopia, leading to more investment and rapid economic development in recent years.





2. Djibouti: Pioneering the Free Zones to Achieve Economic Transformation and Job Creation for Djibouti: From the Perspective of New Structural Economics

In 2016, the CNSE cooperated with China Merchants Group, "Made in Africa Initiative", and Finance Center for South-South Cooperation to help Djibouti build a pilot Free Trade Zone, which aims to attract labor-intensive processing enterprises from China. The research report based on first-hand field research provided action-oriented policy recommendations for zone regarding target industries and policy incentives.

3. Benin: Leveraging Special Economic Zones to Capture the Window of Opportunity for Structural Transformation in Benin: from the Lens of New Structural Economics

In 2016, Prof. Justin Yifu Lin visited Benin by the invitation of President Patrice Talon and signed the project agreement with the Minister of Finance of Benin. The research team from Department of International Cooperation then visited Benin multiple times for in-depth research and investment promotion. Under this project, the team helped the Benin government to promptly formulate and promulgate the Law of Special Economic Zones, improve the business environment in the zones, explore financing channels to formulate a sustainable business model for the zone development, in order to overcome the binding constraints and eventually achieve economic transformation. The project has formulated multi-partnerships with both Chinese and international stakeholders for zone development, and successfully attracted anchor investors in manufacturing who have signed MOU with Benin

4. Nigeria: Leveraging Special Economic Zones to Capture the Window of Opportunities for Structural Economic Transformation: from the Lens of New Structural Economics

government in 2018.

In June 2016, Prof. Justin Yifu Lin signed a project agreement with the Minister of Industry of Nigeria. The research team later visited Nigeria multiple times for in-depth field research. The research conducted diagnosis on Nigeria's comparative advantages, potential industries, binding constraints and the status of Special Economic Zones. Based on the research, the team provided action-oriented policy recommendations for the Nigerian government. Under the project, in January 2018, the team organized a visit in China for the Nigeria Investment Promotion Delegation led by the Minister of Industry, to learn China's successfully experience in developing textile and garment sector, and helped Nigeria to establish partnership with a leading textile group of China. Based on Nigeria's comparative advantage, the team continues to explore investment promotion opportunities from different channels.

5. Poland: Implementation of NSEs in Poland

In October 2015, the new Polish government announced that it would adopt the NSE as the theoretical basis to formulate its development plan. Soon it launched the "Comprehensive Development Plan of Poland", which aims to combine the "effective market" and the "facilitating government" to promote economic development. Appling NSE theory and GIFF framework, the Plan identified Poland's comparative advantages, defined government facilitation role and formed detailed industrial policies. Later on, Mateusz Morawiecki, the Prime Minister of Poland, specifically explained why Poland adopted NSE as the theoretical basis for its international development strategy.

7. Pakistan: Facilitating China–Pakistan Economic Corridor (CPEC) Development

In May 2017, witnessed by the Minister of Planning and Development of Pakistan, Prof. Justin Yifu Lin and the Pakistani head of CPEC signed a memorandum of cooperation, which aims to adopt NSE as the theoretical guidance to the development of special economic zones, and the design of policy incentives for attracting foreign investment. The goal is to facilitate the CPEC construction and help Pakistan achieve economic transformation. The research team advanced the progress of the project by actively encouraging Chinese labor-intensive enterprises to invest in Pakistan. The team has translated the theory and wisdom of China's growth into practical projects to create jobs, enhance exports and boost the host country's economic growth.

8. Uzbekistan: Operationalizing the Use of Industrial Parks to Set Up Footwear Cluster in Uzbekistan

In November 2018, Prof. Justin Yifu Lin and Aloqabank, a development bank in Uzbekistan, signed the project agreement to provide practical policy advisory for the establishment and development of the industrial parks in Uzbekistan. The project aims to help Uzbekistan to leverage the current "Going out" demand of Chinese labor intensive footwear manufacturing, by attracting footwear manufacturers to build production base in Uzbekistan, create jobs and export, form footwear cluster and eventually contribute to economic transformation.

6. Facilitating Economic Transformation: Research on Chinese Manufacturers

In 2017, the INSE and the UK-based Think Tank, Overseas Development Institute (ODI), jointly conducted an extensive in-depth survey on total 640 foreign trading companies in the Yangtze River Delta and the Pearl River Delta, covering four main labor intensive manufacturing sectors, apparel, footwear, toys and household appliances. The outcome report "Adjusting to Rising Costs in Chinese Light Manufacturing—What Opportunities for Developing Countries?" pictured and analyzed the transformation and upgrading path of Chinese light manufacturing, and documented the motivation and experience of the "Going Out" in response to the rising labor cost in China.



Policy · Achievement

Projects Supported by China Top Think Tank Fund

1. New Economy and Reconstruction of Industrial Policies

At present, China is undergoing profound changes featuring the rise of the new economy. Data have increasingly become a major production factor. A series of big data-related emerging industries have sprung up, including cloud computing, Internet of Things and artificial intelligence, driving the upgrading of traditional industries. This project aims to explore the orientation of the development strategy and industrial policies under the new economy and compare them with the industrial policies of other major countries. Based on the latest development of the global new economy, four typical cities are selected for case study, namely, Shenzhen, Shanghai, Hangzhou and Shenyang. It is expected to release a think tank report, a monograph and a series of academic papers.

2. New Structural Economics on Specialty Agriculture

"New Structural Economics on Specialty Agriculture" is a major case study project, which attempts to apply NSE to study the basic laws of the





transformation and upgrading of agricultural and non-staple food processing industries, and summarizes the important role of "effective market" and "promising government". The expected results include case collections, monographs and media articles.

Domestic Think Tank- Local Government Cooperation Research Projects

1. Hejian City: Industrial Transformation and Upgrading Research

From December 2015 to May 2016, the CNSE collaborated with the Hejian Municipal Government of Hebei Province to carry out the research project. An extensive survey has been conducted on key industries in Hejian City, and the "Hejian City Industrial Transformation and Upgrading Research Report" was published. On May 21, 2016, the New Structural Economics Teaching, Research and Policy Practice Base was established in Hejian City.

2. Tibet Autonomous Region (TAR): Research on the Innovation of Government, Market and Tibet Development Concept

From April 2016 to September 2017, the CNSE and the TAR Government jointly carried out a project, and published "*Research Report on the TAR Special Industries Development*". The team has paid field visits to Tibet five times and conducted an extensive survey. From the perspective of the NSE, it analyzed the status quo and challenges of the special industries development in Tibet and proposed effective solutions for transformation and upgrading.

3. Jilin Province: Economic Structural Transformation and Upgrading Research

From October 2016 to August 2017, the CNSE together with the Jilin Provincial Government conducted a project titled *"Research on the Economic Transformation and Upgrading of Jilin Province"*. Based on the industries with potential comparative advantages in Jilin Province, the team demonstrated the 5 industrial clusters whose output will surpass 1 trillion yuan each in the future, namely modern agriculture, healthcare, equipment manufacturing, textile and the integrated industrial cluster with new energy, new materials and the next-generation information technology as its core.



4. Zhongshan City: Industrial Transformation and Upgrading Case Study

In October 2016, the CNSE and Zhongshan Municipal Government signed a strategic cooperation agreement and cooperated with Zhongshan Municipal Bureau of Commerce to carry out a research project titled "Zhongshan City Industrial Transformation and Upgrading Case Study". The team made a thorough research on the status quo of key industries and the bottleneck for transformation and upgrading. Based on the research and judgment on the development stage and factor endowments structure of Zhongshan City, the team diagnosed the city's current core issues, and put forward suggestions on the roadmap and policy strategy for industrial transformation and upgrading as well as the facilitating role of the government.

5. Datong City: Economic Transformation and Upgrading Research for the Resource-based City In August 2018, at the invitation of Datong Municipal People's Government, Prof. Justin Yifu Lin led a team to visit the city to study its economic

transformation and upgrading and signed an agreement to carry out the "*Research on the Transformation and Upgrading of Resource-Based City of Datong*". Guided by the NSE and based on the project and the local workstation, the team will help Datong, a resource-based city to realize transformation and upgrading. Besides, it will take Datong as a typical case to systematically explore the transformation and upgrading experience and policy measures for China's resource-based cities, making resources "a bless" instead of "a curse" for those cities.

6. Jincheng City: Industrial Transformation and Upgrading Case Study

Entrusted by the Jincheng Municipal People's Government, in July 2018, Prof. Justin Yifu Lin led a domestic think tank team to visit Jincheng, Shanxi Province, to study the local economic and social development, factor endowments structure and related industrial bases. Prof. Lin gave a lecture titled "Transformation and Upgrading of Resource-Based Cities: A Perspective of New Structural Economics". Based on the NSE, the team will take Jincheng City as an important case to discuss and explore the issues related to transformation and upgrading of resource-based city, and provide policy recommendations for the city.

7. Hotan: Industrial Poverty Alleviation Special Pilot Area Plan and Oasis Economy-based Poverty Reduction Case Study

Entrusted by the Hotan Prefectural Administrative Commission, since 2016, Prof. Justin Yifu Lin has led the team to visit Hotan multiple times to study industrial relocation and investment promotion. Based on the investigations, the proposal for Hotan Industrial Poverty Alleviation Special Pilot has been submitted to the central government on many occasions. The project is the implementation of this proposal, and the expected results include a plan of the Special Pilot Area and case study reports.
